The Clarence City Council, pursuant to Section 87 and Section 89 of the *Food Act 2003* hereby registers the premises known as **Juicy Isle Pty Ltd** situated at **10 Runway Place CAMBRIDGE Tasmania 7170** as a food business for the handling and or the sale of food detailed in the application for registration of a food business subject to the following conditions:

- This certificate of food business registration is issued based on the information provided in the application
  - This registration certificate is only valid for the sale of the following foods: (list of foods detailed in application)
    - Fruit juice, cordial, syrups, toppings, water and carbonated beverages.
    - Wholesale of packaged goods
2. Product testing for all apple-based product for export (100% testing regime). Product can only be released if the level of patulin does not exceed 50 micrograms/kg (50ppb) or other such level required by the importing country. Testing must be undertaken by a laboratory accredited by NATA for patulin analysis.
3. As an addition to existing quality assurance systems, development of a Patulin Management Plan (PMP) designed to limit the level of patulin in apple juice products to a maximum level of 50 micrograms/kg (50ppb). The PMP must include mandatory verification testing by a laboratory accredited by NATA for patulin analysis.
4. A copy of the PMP is to be provided to Council by 1 June 2020.

**Review:**

In accordance with Section 93, you may apply to the Magistrates Court (Administrative Appeals Division) for a review of decisions relating to registration within 28 days after –

- a) Issue of the certificate of registration under Section 87 (6) or renewal of registration under Section 89 (4); or
- b) Receipt of a notice of refusal under Section 87 (7) or Section 89 (5); or
- c) Service of a notice of variation, suspension or cancellation under Section 91 (5).
